1. PROJECT DESCRIPTION: Westminster Presbyterian Church will provide a warming center for homeless persons in the Portage/Kalamazoo community on Tuesdays and Thursdays from November 14 through March 28 from 10 am until 2 pm. Two warming centers provided shelter from the cold last winter on a temporary basis, covering four days of the week. These centers provided a place to rest, enjoy a warm drink, snacks, a warm meal, and food to take with them. Other resources including clothing and access to some services helpful to the homeless were also provided. These centers were located in different parts of the city. The one nearest to us, staffed by the volunteer Coalition for the Unhoused, served about fifty people per day. We hoped to work with them, providing shelter on alternate days. However, it appears that the organization running that center may not be able to open the center for the coming winter, increasing our conviction that there's a need we can be involved in addressing.

Homelessness is a significant and persistent problem in Kalamazoo County, including both the city of Kalamazoo and adjacent Portage. It's difficult to obtain accurate numbers. Some sources estimate approximately 700 homeless persons at any given time, in a county of 260,000, but this is widely believed to be an undercount, and doesn't include those who are sporadically unhoused. There are significant encampments throughout the area including a nearby highway underpass and a park about a mile from our church. Though we are in what might be considered a suburban area, it's become clear that homelessness is not limited to urban or inner city areas, but is increasingly visible where many did not previously believe it existed. A severe lack of affordable housing as well as systemic poverty contribute. There has been much public conversation around these concerns, but thus far, comprehensive countywide solutions have not materialized. We certainly do not expect a warming center to solve these larger systemic issues, but we hope to be part of a safety net of support while also contributing our voices to the wider conversation.

Our task group of seven is working hard to get things in place for this new ministry of the church. We are in process and expect to have our kitchen licensed soon so that we can prepare and serve hot meals. We'll be hiring a security person to be present during the hours of operation. Our lead coordinator has extensive experience as executive director of a community ministry serving a diverse and largely unhoused population. In addition to recruiting and training volunteers from the congregation, we have assurances that congregations from our local interfaith clergy caucus will also be contributing volunteers, some of whom have experience from working at one of the warming centers last winter. The Coalition for the Unhoused, also has a network of volunteers we can tap, and have been a helpful resource in our planning process.

Our intent is to begin slowly, by providing a warm place to rest and warm food and drink. When volunteer time and resources allow, we hope to provide for other needs including showers, warm clothing and bus tokens. We also hope to partner with other

area organizations to provide or connect people with other services in the Kalamazoo area such as basic healthcare, substance abuse, treatment and assistance programs.

Our primary goal is simply to provide a warm and safe place for our homeless neighbors on a cold day. But beyond that, we see this new ministry as a way to extend our outreach to a neglected community of people. We previously engaged with the homeless by serving meals at Ministry with Community, an organization providing meals and a variety of other services in downtown Kalamazoo, about six miles from our church. The pandemic interrupted this. As a predominantly white, educated, and fairly prosperous faith community, we see the importance of engaging with those whose experience is different from our own. So we hope to raise our awareness of the problem of homelessness in our community and gain a better understanding of the issues. We also hope to begin to build bridges of relationship, to get beyond stereotypes and know our homeless neighbors as individuals. We know it's important that the "cries of the homeless" be defined not by our assumptions of what they need, but by their own voices.

Thirdly, having listened to the homeless, we hope to be better advocates for their expressed needs. Fourthly, we hope to become effective partners with others who are already engaged in this important ministry in our area.

2. MISSION, VISION AND PLANS OF CONGREGATION

Our congregational intention statement reads; "At Westminster, we live a whole life in response to God, attentively, together, engaging the world for the good of all, in response to Jesus Christ." We view "engaging the world" as a crucial part of being a vital congregation. We recognize that our faith community lacks diversity in a number of ways and that it is therefore important for us to connect with others beyond the walls of our church. Westminster is a charter member of ISAAC Kalamazoo, a multiracial inter-faith advocacy organization that currently focuses on anti-racism, gun violence prevention, and housing concerns. Our members volunteer in various service agencies within the county, and we financially support many of these. There are many ways "to engage the world," but we feel called to fill this particular need in the community for a warming center for those without a place to go. It's a new way for us to live out one of our core values, compassionate service. Since the addition of a fellowship hall and kitchen in 1999, the congregation has felt strongly that the facility should be used for mission. For about ten years we shared this space with a Senior Adult Day Program. Since that program moved to its own dedicated space just before the pandemic, we have been looking for other ways to use our building for mission.

In January of 2023, the Session adopted a statement about racism which opens with: "As people dedicated to following Jesus Christ, it is our desire to respond to all people in the open, inclusive, and compassionate way of Jesus. We believe the church should strive to be the 'Beloved Community' in which all find welcome, respect, and hope." The statement goes on to say "that healing the wounds of racism serves the common good. This means becoming aware of the ways and places in which racism is present...." We know that people of color are overrepresented in the

unhoused population, and recognize that racism plays a role in the lives and circumstances of those who will use the warming center. We expect to learn and be challenged by a deeper awareness of the ways racism manifests itself in our society.

3. PLANS FOR EVALUATION

We will be keeping records of numbers of people served, volunteers participating, and other needs identified by those we serve, as well as expenditures. The task group planning this outreach will continue to meet and review the process and outcomes. We will consider the project a success if even a few find shelter from the cold, but we hope to be able to serve, on average, at least 25 people per day. Our goal is to have a minimum of five volunteers per day and a volunteer base of at least 25 individuals.

It will also be important for us to evaluate the sustainability of the project. Is the number of volunteers adequate? Were actual costs comparable to projections? Can ongoing funding be secured? What other support services will be possible, given the financial and other resources available? Have we been able to build working relationships with other local groups and agencies who can help?

4. SUPPORTING DOCUMENTS

There are no supporting documents to attach but it's worth mentioning that we've been consulting with the Kalamazoo Coalition for the Unhoused and other organizations who have done similar work in our community. We have also secured a commitment of support from Kalamazoo Loaves and Fishes (regional food bank) to supply food.

6. PROJECT SITE

The warming center will be located in the Westminster Presbyterian Church building at 1515 Helen Avenue, Portage, Michigan. The property (1515 Helen Ave) sits at the end of a cul-de-sac on thirteen acres adjacent to Interstate 94 and the border between Portage and Kalamazoo.

The area of the facility which will be used has its own entrance, lobby, a large gym/fellowship hall, two restrooms (with showers), and a kitchen with pantry. Access to the rest of the building will be restricted. The kitchen has a large commercial refrigerator, freezer, dishwasher, and stove/oven with hood (fire suppressant system attached). We are currently working with the county health department on licensing the kitchen.


